### **Course Description**

This course surveys some of the work of philosophers active from the late 4<sup>th</sup> century CE to the end of the 12<sup>th</sup> century CE. During this period, the Western Roman empire collapsed and two monotheistic religions ascended to cultural, social, and political dominance: Christianity in Western Europe and Asia Minor, Islam in Western and Central Asia, North Africa and the Iberian Peninsula. This was the period of Charlemagne's unification of Europe and the Carolingian Renaissance, the Abbasid Caliphate and the Islamic Golden Age, and the Renaissance of the 12<sup>th</sup> century that produced Scholasticism and the medieval university. As part of these immense changes, ancient Greek and Roman thought was repurposed and redeployed by a succession of Christian, Muslim and Jewish philosophers. These thinkers were responsible for significant developments in philosophical thought about various topics: freedom and the will, knowledge and perception, the nature of the divine and the physical world, and, of course, reason and faith. Whether we agree or disagree with the conclusions and claims of these thinkers, their rigorous reasoning, conceptual originality, and philosophical insight are well-worth thinking about as much today as during their own times.

#### (1) Reading Questions

**Value:** 10% per assignment, 3 assignments (total value = 30%)

**Assignment:** Short answer questions on the forthcoming week's readings. The answers must be submitted online. The questions will be assigned a few days before the due date. Late submissions will automatically receive a "0."
