#### 4. Officers' Reports

#### 4.1 President's Report – David Docherty

It was a busy year with some successes and some challenges and frustrations. Successes: The 50<sup>th</sup> Anniversary celebration for UVic directly involved the UVRA. Victor Neufeldt compiled the history of the UVRA and is looking for pictures to include with the text. It will be made available to members when it is complete. The Events Committee was very active this year and there was more participation than ever. The Masterminds series was also very popular.

A Board Retreat was held with Board members and others that have played a role in the UVRA to look at what we are doing now and where we need to go looking forward. Works in progress:

- The development of a Memorandum of Understanding between UVic and the UVRA. David met with the President and as a result the UVRA is now written into the University's Strategic Plan. He is working with John Schofield on this project.
- To develop and present workshops to members and those soon to be retired regarding CPP, benefits and other subjects important to this group.

- To provide an alternative option to Pacific Blue Cross for EHB, travel insurance and dental coverage for UVRA members.
- Elder Academy Offer programs and activities specifically designed for 55+ retirees. Beverly
  Timmons has been working to bring this idea to fruition. A draft proposal has been
  prepared. Good momentum was established with Valerie Kuehne, VP External Relations,
  who has now left that position. Grant Hughes, the Director of Community Relations, has
  provided access to Carmen Charette, the new VP, who is also supportive. There have been
  meetings with several groups on campus including Continuing Studies and the Centre on
  Aging (Bev is the UVRA representative on their Board). The Alumni Association, the
  Development Office, AVP Research have also shown interest.

A very successful Volunteer Recognition luncheon was held in April with Lois Holizki as the speaker. This will be a yearly event in April during Volunteer Recognition week.

David thanked all Board members for their ideas, work and support over the past year. **Motion:** "That the Report be accepted." (D. Docherty/G. Poulton) <u>Carried</u>

#### 4.2 Treasurer's Report – Kathy Harris

The Treasurer submitted the Treasurer's Annual Report for 2012/13. Linda Sproule Jones asked what the major expenditures were in the year. They were for CURAC (which was held at UVic this year), new computer in office, expenses for conducting a members survey, the volunteer lunch and the Board Retreat.

#### 7. New Business

- Kathy Harris reported on the results of the member survey that was sent out with the membership renewal forms this year. The completed surveys were given to the Events Committee and the Membership Committee for their review. A hard-copy of the results is available for members to see in the UVRA office, and all attendees at the AGM have been given a copy. The cost for preparing and sending out the survey, including postage-paid return envelopes, was over \$700.
- Victor Neufeldt mentioned that on-campus parking permits are now available to all UVic retirees, not just UVRA members.
- Peter Liddell said that negotiations with UVic to make reduced-fare bus passes available for UVRA members were unsuccessful.
- Work is still underway by Victor Neufeldt on his history of the UVRA. The text is complete but design and production is still necessary.

David Docherty thanked the members of the Board for their service. He especially thanked Peter Zingeler and Mel Klassen for their work on the newsletter, which has been well received. A copy is sent to every unit on campus and there has been a very positive response. He also gave a special thanks to Kathy Harris for her great ideas and contributions which were above & beyond her duties as Treasurer. He welcomed Linda Metters as Secretary and Rashna Charania as Treasurer.
