Report on the Elder Academy: 2022 AGM (October 2021 to June 2022)

Overview of presentations:

From October to June there were 5 series and one lecture presented by the UVRA Elder Academy with 407 registrants (see Appendix for details). There were 24 presentations with 22 different presenters. The presenters ranged from current faculty sharing their field of research, community resource people, national media and writers, local physicians, and members of the UVRA.

Due to COVID most of the presentations were via Zoom which allowed for the Elder Academy to call upon international speakers for some of the series. The last two series used a Hybrid Model in which presentations were made to an in-person audience and simultaneously zoomed to others who had registered. All presentations were recorded and made available via YouTube for those who had registered and wished to review the presentation or were unable to attend on the day. The slides for all presentations were made available on the UVRA Website.

The presentations were promoted through several sources including the UVRA membership, the Elder Academy list, the Institute of Aging and Lifelong Health (IALH), CURAC Later-Life-Learning electronic list, senior centres, and by word of mouth. Details on the presentations were sent to the lists 4 weeks, two weeks and one week prior to the first presentation. Registration was done on Eventbrite which worked well.

Financial summary:

The Elder Academy Series for the 2021-2022 period generated revenue of \$9,311.24 and expenses of \$5,155.50 for a net income of \$4155.74.

Special thanks:

A special thanks should be extended to John Gunton for taking on the Chair of the Programming Committee and providing excellent leadership for the past three years. For the past two years we have had to deal with the challenges of COVID and the restrictions this placed on running the program. He worked tirelessly in identifying topics and searching out presenters. Also a special thanks to Sanjit Roy for all the work he did

in setting up the presentations, including registration. He has been a great asset in putting on the various series. Appreciation should be extended to John Arduini for uploading all the presentations onto YouTube and more recently for providing the technical support for the hybrid presentations. We were fortunate to be able to use the facilities at Cordova Bay 55+ Association to offer both the in-person as well as the Zoom options to the registrants.

Future of the Elder Academy:

Part way through the year there was much discussion in the Committee about the sustainability of the Elder Academy. It is clearly a lot of work for a small group of volunteers with no assistance from the University. John Gunton undertook a review of similar programs in other institutions as well as what was being offered by UVic Continuing Studies. The analysis showed that other institutions offering a similar program received considerable financial support. In addition, UVIc Continuing Studies are now offering a wide range of educational opportunities to a wide demographic at a reasonable cost to participants which was not the case when UVRA decided to run the Elder Academy. Based on the analysis it was decided, with regret, to recommend to the UVRA Board that the Elder Academy be disbanded. The recommendation was approved by the Board.

However, members of the committee offered to work with the University and Continuing Studies in setting up some central system that would make it easy for the general public to see what is being offered at UVic by various groups and organizations on campus. At the moment it is difficult to find this information. One of the recommendations would be to establish a "Department or Institute of Life Long Learning" which could clearly list all the educational opportunities on campus open to the general public and offered by the different faculties and departments, which the analysis showed are extensive. This would certainly be one way the University can fulfil its mission to serve the local community and provide ongoing learning opportunities for an older demographic.

For the past 7 years the Elder Academy has performed a valuable role and contribution to the community in offering quality presentations on a variety of topics. The UVRA and UVic has received considerable recognition in regard to the Elder Academy with literally thousands of participants and very positive feedback. So it is unfortunate that the program is being disbanded. In many ways it has been the flagship for the UVRA. The program committee would like to take this opportunity to thank all those that have helped with the Elder Academy over the years, especially those who have given generously of their time and talents in presenting as well as those many people who have supported the program with their attendance.
