The PLLC is an interdisciplinary, University of Alberta initiative, that provides leadership skills development to undergraduate and graduate students, designs bespoke leadership programs for various university constituencies (students/staff/faculty), and convenes leadership workshops and events for the broader community. This proposal was unanimously approved by the University of Alberta's Signature Area Development Panel and was approved by Deans' Council (March 9, 2018). We acquired an internal grant of \$97,000 to support the work of IG for three years. The goal of the initiative is to build the foundations for interdisciplinary collaboration, showcase the research and teaching strengths of UAlberta scholars and develop collaborations and partnerships with external partners.

The ADR is responsible for supporting approximately 350 faculty members and postdoctoral fellows in 15 departments in identifying funding opportunities, grant writing and review; representing the research interests of the Faculty of Arts on the University Research Policy Committee and SSHRC Associate Deans committee; nominating faculty members for major internal (Kaplan, Piper) and external research awards (Canada Research Chairs; Royal Society Fellowships; Killam Fellowships SSHRC Impact Awards; Banting Postdoctoral Fellowships) chairing internal grant committees (Support for the Advancement of Scholarship; Landrex Professorship; McCalla Professorship, Faculty Research Awards; Roger S. With the restructuring of FGSR in 2013, the responsibilities of the AD(GS) increased substantially and could no longer be combined with the ADR portfolio.

Major Accomplishments:

- Arts in 60 Seconds Developed and oversaw the production of 20 short videos of scholars in the Faculty of Arts describing their research. This initiative was to promote both the work of individual researchers in the Faculty as well as provide a sense of the breadth of the subject areas that Arts engages.
- Facilitating Collaborations Hosted a number of events designed to connect colleagues within SSHRC disciplines at the U of A, as well as colleagues and community members with the aim of facilitating research collaborations and promoting scholarship.
