

### Meeting of Senate February 2, 2024

### MINUTES

A meeting of the Senate of the University of Victoria was held on February 2, 2024 at 3:30 p.m. in the Senate and Board Chambers, Jamie Cassels Centre, Room A180.

Kevin Hall called the meeting to order and offered a territorial acknowledgement. He thanked Vice-Chair Robin Hicks for chairing the last few meetings in his absence.

#### 1. APPROVAL OF THE AGENDA

K. Hall advised two items were being removed from the agenda by the Senate Committee on Academic Standards. These were items 6(a)(ii) and 6(a)(iii).

Motion: (Y. Kandil/P. Loock) That the agenda be approved as amended.

#### 2. MINUTES

#### a. January 5, 2024

<u>Motion</u>: (J. Salinas/A. Newcombe) That the minutes of the open session of the meeting of the Senate held on January 5, 2024 be approved and that the approved minutes be circulated in the usual way.

#### 3. BUSINESS ARISING FROM THE MINUTES

There was none.

#### 4. REMARKS FROM THE CHAIR

#### a. President's Report

K. Hall acknowledged that February is Black History Month, a time to honour the legacy of Black people in Canada. He outlined some of the events on campus to celebrate and on videos that were available, all due to the great work of the Scarborough Charter Steering Committee.

K. Hall reported that February 11 was the International Day of Women and Girls in Science, noting that diversity in science research is critical and this day is a reminder that women and girls play a critical role in science and technology communities.

K. Hall offered congratulations to Lisa Kalynchuk for her re-appointment as Vice-President Research and Innovation.

K. Hall provided an update on awards:

- UVic received a record number of Royal Society of Canada fellowships or college of new scholars in 2023.
- Graduate student in Chemistry, Nicholas J. Roberts was the winner of the Gilead Early Career Award for Excellence in Equity, Diversity, and Inclusion for his work in the advocacy and leadership in supporting students with invisible disabilities.
- Dr. Makhsud Saidaminov, Assistant Professor in Chemistry and Electrical and Computer Engineering won the Keith Laidler Award for outstanding early-career contributions to physical chemistry.
- Dr. Lisa Reynolds from Biochemistry and Microbiology won the Canadian Association of Gastroenterology Early Career Research Prize.
- Vikes women's rowing coach, Jane Gumley, was a finalist for the BC Sports Coach of the Year.

Finally, K. Hall advised that every year the university was asked to submit its capital plan, and as part of the submission the university's top priority was 500 beds of new student housing. The university has been invited to develop a business case for Spring of 2025.

A member of Senate asked if an update could be provided on the Federal Government's announcement on the restrictions for international students. K. Hall reported on the Federal Government's plan to issue visa applications and how those will be allocated to each of the provinces. He said those that are allocated to British Columbia would then have to be allocated across each of the post-secondary institutions across the province. K. Hall commented on the potential implications for UVic and on outstanding issues to be resolved.

Elizabeth Adjin-Tettey, Chair of the Senate Committee on Planning, introduced the proposal.

A member of Senate commented that they found the curriculum outline confusing and hard to navigate, especially the unit values, and thought there could be clarity on how they were calculated.

That Senate approve, and recommend to the Board of Governors that it also approve, the proposed changes to the BSN University of Victoria and College Partners program in the School of Nursing, as described in the document "University of Victoria and College Partners BSN Program".

#### 9. OTHER BUSINESS

#### a. Re-Appointment of an Orator for the University of Victoria

Carrie Andersen, University Secretary, introduced the proposal. There were no questions.

#### b. 10-Year Sessional Calendar

C. Andersen introduced the revisions to the sessional calendar.

A member of Senate commented that most terms consisted of 59 days in length and given the recent closures of the university due to weather, this impacted on the ability to deliver an effective academic program. C. Andersen acknowledged the multi-faceted nature of the issue, and indicated that consideration how to address term length, course scheduling and the exam period would require careful consideration.

<u>Motion:</u> (J. Salem/A. Mallidou) That Senate approve the 2023 – 2033 10-Year Sessional Calendar.

#### c. Academic Important Dates

C. Andersen introduced the revisions to the Academic Important Dates.

A member of Senate noted that the last day to pay fees was September 30<sup>o</sup> which was a statutory holiday, and was looking for assurance that students were not impacted by the university being closed. K. Hall said inquiries would be made into the question. Another member of Senate commented on the number of missed Monday class days. C. Andersen confirmed that this was a long-standing concern raised by members of Senate.

<u>Motion:</u> (L. Wilson/J. Salem) That Senate approve the Academic Important Dates for the period May 2025 through December 2025 for submission to the May 2024 undergraduate and graduate academic calendar publications.

### d. 2024/2025 Senate Meetings Dates

C. Andersen introduced the list of meeting dates for next academic year.

A member of Senate commented on the traditional cycle of Senate meetings, noting that some faculty worked all year round, and there were faculty that did not necessary teach during the fall. K. Hall acknowledged this and noted that the Office of the University Secretary would look at this.
